SPACE ASSIGNMENT

- FIRST COME, FIRST SERVED BASIS (based on receipt of payment with complete application).
- Local merchants are given the spot directly in front of their business.
- Every effort will be made to accommodate vendors who have regularly participated in the Springfest.
- You will be notified of your space assignment ***48 HOURS*** prior to the event by email or go to our website **www.LindenhurstChamber.org** and click SPRINGFEST to view map. NO CHANGES ONCE ASSIGNMENT IS GIVEN.
- Subletting of store front space is forbidden.

SPACE SIZE AND SETUP

- Space size: 10x20 ft. If bringing a tent, bring something to anchor down the tent in case of wind.
- Set up starts AFTER 10:30 AM on the day of the event. No vehicle parking on the street.
- Vendors must supply their own table, chairs, booths, trash containers and disposal bags.
- Electrical power is not available; vendor can supply their own QUIET power source.
- Contact the Chamber to discuss any special requirements.

REQUIREMENTS and RESTRICTIONS

The following items may not be sold or distributed during the Springfest:

- Alcoholic Beverages
- Shaving Cream
- Colored Hair Spray or any type of spray paint
- Liquid String
- Political or Religious Position Material
- Other Restrictions May Apply

SALES TAX COLLECTION: Certificate of Authority for sales tax collection should be available for inspection upon request.

FOOD VENDORS: You must provide a Food Service Vendor certificate. Contact the Suffolk County Health Department for information and an application. **You cannot operate without one.** The Committee reserves the right to limit the amount of food vendors offering similar menus.
